This is in continuation with the provisional admission list for class XI (Ref. No.: SVSU/2025/FS/519 Date: 28-04-25), the candidates listed in **Table 01** were allotted seats during the **1st Counselling** but **did not report**. Their names are mentioned below. The candidates listed in **Table 02** have been **provisionally selected** for admission to **Class XI** through the **2nd Counselling**. **Table 03** contains the **waiting list** for **Class XI** candidates. These candidates will be considered for **3rd Counselling**, **subject to availability of seats and fulfillment of all eligibility criteria in order of merit**.

General Instructions for Counselling for Admissions in Class-XI (Session: 2025-26)

1. The uploaded list of candidates for Counselling is provisional.
2. The list has been prepared on the basis of marks obtained in entrance exam conducted on 19.04.2025 followed by Skill Test on 24.04.2025 & 25.04.2025. Final merit list is based on the 70% weightage of Aptitude test scores and 30% weightage of the scores of Skill test obtained by the candidate. The merit of candidates having the same marks has been prepared as per the age criterion.
3. The name of applicant in the provisional list does not entitle him/her for admission. The final admission will be made after original document verification followed by fees submission at the time of counselling.
4. Candidate must attend the counseling physically. Candidate who fails to appear as per the given schedule for counselling will not be considered for admission. No

claim for seat due to late reporting or absentees will be considered.

5. The candidate must read the Admission Notice 2025-26 carefully.
6. Any discrepancy in the provisional list may be brought into the notice of school administration before commencement of the counselling.
7. The school may conduct another round of counselling in case any seat remains unfilled during first round of counselling.
8. The candidate must bring all relevant original documents in support of their educational qualifications along with one set of attested photocopies of all the documents at the time of counselling.

3. Domicile Certificate is mandatory for the candidates admitted on reserved seats of residents of Dudhola village.
4. Candidate will not be allowed to take admission if not providing 10th Original Mark sheet/Qualifying Exam Marksheet at the time of counselling
